Motion Kjetland, seconded by Schoenrock to approve drainage permit #22-30 for Rigg's Farms Inc. to tile in the NE4 21-102-58 as the following conditions have been met: project does not affect govt property; does not drain a fish or wildlife lake; does not impact a meandered lake; does not affect another county; converts noncontributing land to contributing land; minimal erosion; water quality and supply will improve; ag production will increase; environmental quality will improve; aesthetics will improved; no fish and wildlife values; receiving watercourse has sufficient capacity; drainage is a reasonable improvement; drainage is an acceptable artificial drain system; amount of water drained is reasonable; design and aspects of the drain are acceptable; sustained flow is acceptable. Waldera abstained for personal reasons, all others voted aye, motion carried.
