

**HANSON COUNTY COMMISSIONERS**  
**MINUTES OF PROCEEDINGS**  
**Tuesday, January 24, 2023**

Chairman Waldera with members Fox, Kjetland and Schoenrock present, called the regular meeting of the Hanson County Board of Commissioners to order on Tuesday, January 24, 2023. Bumgardner was absent.

The pledge of allegiance was recited.

Motion Kjetland, seconded by Fox to approve the agenda. Motion carried.

No conflict of interest.

Motion Schoenrock, seconded by Fox to approve the January 10th meeting minutes. Motion carried.

Clerk of Courts fees collected for the month of December 2022 totaled \$6,561.67.

No citizens input.

Representatives from Brosz Engineering presented options and ideas for correcting and stabilizing the embankment on the 413<sup>th</sup> Ave. bridge in Rosedale township. A traffic count will be done and water levels will be checked daily during the spring thaw to help determine if more money should be spent to make the recommended repairs. As The county does not have the equipment to place the needed rock on the steep embankment it will need to be hired out adding to the expense.

Justin Friese, Hwy Superintendent, presented the haul road agreement McCook County wants signed by Hanson County to haul gravel out of the Schmeichel pit. The States Attorney and Justin are scheduled to meet with McCook County on February 14th regarding the haul road agreement as we feel everyone hauling out of this pit should have an agreement so Hanson County is not responsible for damages done by others.

After discussion it was agreed that no changes will be made to the county issued overweight and over width permits at this time.

At the recommendation of the Hwy Superintendent, a motion was made by Kjetland, seconded by Fox to appoint Seth Hauge as Assistant Highway Superintendent making \$21.50 an hour with a three-month review to evaluate the position. All voted aye, motion carried.

Jim Davies, States Attorney, presented the first reading of Ordinance #54 titled "An Ordinance Prohibiting Obstructing Highway Right-Of-Way with Snow or Other Material". The second reading and adoption of ordinance #54 will be held on February 7, 2023.

At the recommendation of the States Attorney and our insurance company, random drug testing for all county employees will not be imposed. Drug and alcohol testing for CDL holders, probable cause and any accident remains a requirement.

#### Resolution 23-01

BE IT RESOLVED that the Hanson County Commissioners name Brandon Wingert, current Emergency Manager, as the Hanson County appointed designee to request fire suppression resources from the South Dakota Department of Agriculture's Wildland Fire Division as long as Wingert holds the position of Emergency Manager.
