HANSON COUNTY COMMISSIONERS MINUTES OF PROCEEDINGS Tuesday, June 10, 2025

Chairman Bumgardner, with members Fox, Kjetland, Schoenrock and Waldera present, called the regular meeting of the Hanson County Board of Commissioners to order on Tuesday, June 10, 2025.

The pledge of allegiance was recited.

Motion Waldera, seconded by Schoenrock to approve the agenda. Motion carried.

No conflict of interest.

Motion Kjetland, seconded by Fox to approve the May 27th meeting minutes. Motion carried.

No board reports or citizen input.

The Auditor's account balanced with the Treasurer's account in the amount of \$4,307,740.22 in all county, state, civil, school, CD and trust accounts as of May 31, 2025.

Ronnie Roth, Hwy Superintendent, presented two quotes to cut down the large over hanging trees at the intersection of 429th Ave. and 261st St. Dakota Tree & Maintenance \$7,850.00 and Hawkeye Tree & Stump Service \$4,500.00. Motion Kjetland, seconded by Waldera to approve the quote from Hawkeye Tree & Stump Service for \$4,500.00 to remove the trees. All voted aye, motion carried.

Roth stated that Hollaway Construction could remove the washed-out bridge on 413th Ave. for approximately \$60,000.00 with the County constructing a road and pad for the crane. After discussion, the bridge will not be removed at this time. Brosz and Hollaway will see if any other nearby entity would be interested in purchasing the bridge for the cost of removal or Hanson County will use all or parts of it to repair other structures throughout the county. As nothing will be done to the bridge at this time, Eric Prunty, Brosz Engineering, presented the costs to date for the engineering done. If we completely abandoned the project now the County would pay 100% of the costs estimated at \$75,000.00, or pay 20% of costs and accepted what engineering has been done for a cost of \$13,000.00 or authorize Brosz to continue the engineering for an approximate total of \$15,100.00 to complete the process to have the proper engineered plans if the Board would decide to replace the bridge at any time. Motion Kjetland, seconded by Waldera to approve and authorize Brosz Engineering to complete the engineering process of bridge #31-010-149 on 413th Ave. for future use. All voted aye, motion carried.

Motion Kjetland, seconded by Schoenrock to recess Board of Commissioners to conduct business as the Drainage Board. Motion carried.

Reconvene Board of Commissioners.

Motion Kjetland, seconded by Schoenrock to approve expenses up to \$3,000.00 for Brandon Wingert, 911 Coordinator, to co-op with Davison County to upgrade the 911 radio system. All voted aye, motion carried.

Motion Schoenrock, seconded by Kjetland to approve the following:

Resolution 25-06 Resolution of Support

WHEREAS, the Hanson County Commission asserts that the primary duties of the emergency management personnel service are to protect life and property, and they receive intensive and specialized training to carry out those duties; and

WHEREAS, the Hanson County Commission asserts the duties are hazardous to the employee, are physically demanding, and directly subject the employee to a risk of injury or death; and WHEREAS, the Hanson County Commission asserts that the capacity to effectively perform the duties declines with advancing age, resulting in increased risk to both the employee and public and justifying and earlier normal retirement age; and

WHEREAS, the Hanson County Commission acknowledges that both the employer's and employee's contribution to the SD Retirement will increase by 2%, and family benefits are not payable upon the death of a member who has reached normal retirement age.

NOW THEREFORE BE IT RESOLVED, that the Hanson County Commission through its June 10, 2025 meeting, supports the Emergency Management position(s) being classified as Class B Public Safety. This said resolution was declared duly passed and adopted.
