

**HANSON COUNTY COMMISSIONERS  
SPECIAL MEETING MINUTES  
Wednesday, June 18, 2025**

Chairman Bumgardner with members Fox, Kjetland, Schoenrock and Waldera present, called the special meeting of the Hanson County Board of Commissioners to order on Wednesday, June 18, 2025.

Today's special meeting was held to canvass the Hanson County election results for the Davison-Hanson Ambulance Board election held on June 17, 2025 and to approve three plats recommended by the Zoning Board after being seen at their special meeting held June 13, 2025.

The pledge of allegiance was recited.

Motion Waldera, seconded by Fox to approve the agenda. Motion carried.

It was moved by Fox, seconded by Schoenrock to approve the Davison-Hanson Ambulance Board election results for Hanson County as reported. Kluth, 82; Nesheim, 269; Goldammer, 27; Huber, 308; Bishop, 64; Blumenberg, 132; Roster, 66; Hofer, 62; Leitheiser, 259; Berg, 273. All members voted aye, motion carried. Hanson County had a 13% voter turnout.

Motion Schoenrock, seconded by Fox to approve a PLAT OF TRACT 2 OF SCHEUREN ADDITION, A SUBDIVISION OF PART OF OUTLOT F IN GOVERNMENT LOTS 3 & 4 IN THE NW4 OF 3-104-57 OF THE 5<sup>TH</sup> P.M. HANSON COUNTY SD. All members voted aye, motion carried.

Motion Kjetland, seconded by Schoenrock to approve A PLAT OF LOT 9A IN BLOCK 3, KROEGER OF THE 5<sup>TH</sup> P.M. HANSON COUNTY SD. All members voted aye, motion carried.

Being as there was no further business for the day, motion Waldera, seconded by Schoenrock to adjourn until June 24, 2025. All voted aye, motion carried.
